## A BILL

To amend the Securities Exchange Act of 1934 to prohibit the Securities and Exchange Commission from requiring an issuer to disclose information relating to certain greenhouse gas emissions, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Protect Farmers from  
5 the SEC Act”.

1 **SEC. 2. PROHIBITION ON REQUIRING AN ISSUER TO DIS-**  
2 **CLOSE INFORMATION RELATING TO CERTAIN**  
3 **GREENHOUSE GAS EMISSIONS.**

4 Section 23 of the Securities Exchange Act of 1934  
5 (15 U.S.C. 78w) is amended by adding at the end the fol-  
6 lowing:

7 “(e) PROHIBITION ON REQUIRING AN ISSUER TO  
8 DISCLOSE INFORMATION RELATING TO CERTAIN GREEN-  
9 HOUSE GAS EMISSIONS.—

10 “(1) DEFINITIONS.—In this subsection:

11 “(A) AGRICULTURAL PRODUCT.—The term  
12 ‘agricultural product’ has the meaning given the  
13 term in section 207 of the Agricultural Mar-  
14 keting Act of 1946 (7 U.S.C. 1626).

15 “(B) DOWNSTREAM ACTIVITIES.—The  
16 term ‘downstream activities’ includes activities  
17 that relate to processing materials into a fin-  
18 ished product and delivering that product or  
19 providing a service to the end user.

20 “(C) GREENHOUSE GAS.—The term  
21 ‘greenhouse gas’ means—

22 “(i) carbon dioxide;

23 “(ii) methane;

24 “(iii) nitrous oxide;

25 “(iv) nitrogen trifluoride;

26 “(v) hydrofluorocarbons;

1 “(vi) perfluorocarbons; or

2 “(vii) sulfur hexafluoride.

3 “(D) UPSTREAM ACTIVITIES.—The term  
4 ‘upstream activities’ includes activities that re-  
5 late to the initial stages of producing a good or  
6 service.

7 “(2) PROHIBITION.—The Commission may not  
8 require an issuer to disclose greenhouse gas emis-  
9 sions from upstream activities or downstream activi-  
10 ties in the value chain of the issuer from the produc-  
11 tion, manufacturing, or harvesting of an agricultural  
12 product.

13 “(3) NONAPPLICABILITY OF EXEMPTIVE AU-  
14 THORITY.—Section 36 shall not apply to this sub-  
15 section.”.
