- 1 Be it enacted by the Senate and House of Representa-

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Just Compensation
- 5 Act of 2023".
- 6 SEC. 2. PURPOSE.
- 7 (a) Constitutional Requirement.—The Fifth
- 8 Amendment to the Constitution of the United States guar-
- 9 antees that "nor shall private property be taken for public
- 10 use, without just compensation".

1	(b) ACT REQUIREMENT.—The purpose of this Act is
2	to require that the Federal Government—
3	(1) demonstrate "public use" by exercising emi-
4	nent domain itself and not delegate the power of the
5	Federal Government to any private entity; and
6	(2) provide just compensation in the form of
7	150 percent of fair market value for any property
8	over which the Federal Government exercises emi-
9	nent domain.
10	SEC. 3. DEFINITIONS.
11	In this Act:
12	(1) Federal Government.—The term "Fed-
13	eral Government'' means—
14	(A) the President; and
15	(B) each Executive agency, as defined in
16	section 105 of title 5, United States Code.
17	(2) Private entity.—The term "private enti-
18	ty" means any non-governmental entity.
19	(3) Relevant congressional commit-
20	TEES.—The term "relevant congress committees"
21	means—
22	(A) the Committee on the Judiciary of the
23	Senate; and
24	(B) the Committee on the Judiciary of the
25	House of Representatives.

1 SEC. 4. PUBLIC USE.

- 2 Notwithstanding any other law, the Federal Govern-
- 3 ment may not delegate the power to exercise eminent do-
- 4 main to any private entity.

5 SEC. 5. JUST COMPENSATION.

- 6 The Federal Government, in exercising eminent do-
- 7 main, shall provide just compensation of not less than 150
- 8 percent of fair market value.

9 SEC. 6. REPORTS.

- 10 (a) Initial Report.—Not later than 1 year after
- 11 the date of enactment of this Act, the Attorney General
- 12 shall submit a report to the relevant congressional com-
- 13 mittees describing the implementation of this Act.
- 14 (b) Subsequent Reports.—Not later than 2 years
- 15 after the date of enactment of this Act, and annually
- 16 thereafter, the Attorney General shall submit a report to
- 17 the relevant congressional committees describing the im-
- 18 plementation of this Act, which shall include—
- 19 (1) a description of the precise actions, loca-
- 20 tions, public uses, and compensations provided for
- 21 every exercise of eminent domain by the Federal
- Government; and
- (2) a summary of the use of eminent domain by
- 24 States.
